**Checklist**

These items **MUST** be submitted to process your rebate. Please keep a photocopy of all materials submitted.

- Fully completed rebate request form.
- A copy of ShowerGuard proof of purchase in the form of a payment receipt

**ELIGIBILITY REQUIREMENTS:** You must purchase a ShowerGuard glass enclosure from a Registered Dealer as listed on the ShowerGuard Dealer Locator. Complete this form and submit it along with a copy of your purchase receipt indicating ShowerGuard was bought from a ShowerGuard Registered Dealer. Rebate only valid to residential/final enclosure purchaser. Purchase dates must be between 1/1/2018 through 12/31/2018. Rebates for 2018 must be received by 1/16/2019.

**DETAILS:** To locate a Registered Dealer, enter your zip/postal code into the Dealer Locator at [ShowerGuardGlass.com](http://ShowerGuardGlass.com). Rebate offer valid only for purchases of ShowerGuard glass from a ShowerGuard Registered Dealer. Offer not valid on submissions from a dealer not belonging to the ShowerGuard Registered Dealer Program. To be eligible for the rebate offer: (1) your submitted materials must be validated by Guardian Glass, LLC; (2) you must have purchased your ShowerGuard glass from a Registered Dealer; (3) your rebate submission must be accompanied by a proof of ShowerGuard purchase in the form of a payment receipt.
